## Compensation - Exempt Salaries <br> ISSUE DOCKET

## Approach taken for exempt salary increases includes:

Salaries for certain exempt positions were increased to $80 \%$ of market average as determined by the State Auditor's Office;
Certain positions that are currently at or above $80 \%$ of market average were provided a $1 \%$ increase in fiscal year 2014 and an additional $2 \%$ increase ( $3 \%$ total over baseline salary) in fiscal year 2015;
Several exempt positions received targeted pay adjustments;
Salaries for elected officials were not considered; and
Judges' salaries were adopted in Article IV.
