Texas Board of Professional Land Surveying Proposed Rider Contingency for SB 617

Overview |

The following action adds a new rider that directs \$480,607 relating to the transfer of the regulation of land surveying to the Texas Board of Professional Engineers, contingent on the enactment of Senate Bill 617, or similar legislation relating to the transfer.

Required Action

On page IX-xx, add the following new rider:

Section 18.xx. Contingency for Senate Bill 617. From funds appropriated above in Article VIII, Page VIII-26:

- a) Contingent on the enactment of Senate Bill 617, or similar legislation relating to the transfer of the regulation of land surveying to the Texas Board of Professional Engineers, by the Eighty-sixth Legislature, Regular Session, \$468,107 in General Revenue and \$12,500 in Appropriated Receipts in fiscal year 2021 are reduced from the Texas Board of Professional Land Surveying.
- b) Contingent on the enactment of Senate Bill 617, or similar legislation relating to the transfer of the regulation of land surveying to the Texas Board of Professional Engineers, by the Eighty-sixth Legislature, Regular Session, the allocation of funds to be transferred to the Health Professions Council by the participating agencies for fiscal year 2021 as required by Section 3, Special Provisions Relating to All Regulatory Agencies, in Article VIII of this Act, shall be adjusted to reduce funds transferred by the Texas Board of Professional Land Surveying to the Health Professions Council and reallocate the amount of any decrease in funds transferred to the Health Professions Council by the Texas Board of Professional Land Surveying for fiscal year 2021 to the other participating agencies.

Article IX Proposed Rider Contingency for Senate Bill 605

Overview

Prepare a rider which reduces funding the Texas Parks and Wildlife Department (TPWD) and increases funding at the Texas Historical Commission (THC) for the purposes of implementing the provisions of Senate Bill 605, which transfers eight historic sites from TPWD to THC, contingent upon its enactment. Note: this rider draft considers funding and authority in Senate Bill 1, As Introduced which appropriates the maximum Sporting Goods Sales Tax allocations to TPWD (Rider 34) and THC (Rider 25).

Required Action

On page IX-xx of Article IX, add the following new rider:

- Contingency for Senate Bill 605 or House Bill 1422. Contingent on enactment of Senate Bill 605, House Bill 1422, or similar legislation transferring the Battleship Texas State Historic Site (SHS), Fanthrop Inn SHS, Fort Leaton SHS, Lipantitlan SHS, Monument Hill and Kreische Brewery SHS, Port Isabel Lighthouse SHS, San Jacinto Battleground SHS, and Washington-on-the-Brazos SHS from the Parks and Wildlife Department to the Historical Commission, by the Eighty-sixth Legislature, Regular Session:
- (a) appropriations made elsewhere in this Act to the Parks and Wildlife Department in Strategy B.1.1, State Parks Operations, are reduced in each fiscal year by \$1,357,209 in General Revenue-Dedicated State Parks Account No. 64 and the Number of Full-Time-Equivalents (FTE) is decreased by 73.0 in each fiscal year;
- (b) any Sporting Goods Sales Tax Transfer to State Parks Account No. 64 appropriated elsewhere in this Act to the Parks and Wildlife Department for the eight historic sites referenced in this provision (\$3,669,491 in each fiscal year in Sporting Goods Sales Tax Transfer to State Parks Account No. 64) is redirected to operation of the department's remaining state parks and sites; and
- (c) appropriations made elsewhere in this Act to the Historical Commission in Strategy A.1.4, Historic Sites, are increased in each fiscal year by \$3,483,700 in General Revenue and by an estimated \$1,543,000 in General Revenue - Fees from Historic Sites and the Number of Full-Time-Equivalents (FTE) is increased by 73.0 in each fiscal year.

Department of Public Safety Motorcycle Operator Training Program Transfer Contingency Rider

Overview

The following action adds a new rider to transfer motorcycle and off-highway vehicle operator training program funding and FTEs from the Department of Public Safety to the Texas Department of Licensing and Regulation.

Required Action

On page IX-xx, add the following new rider:

Section 18.xx. Contingency rider for SB 616. Contingent on the enactment of Senate Bill 616, or similar legislation relating to the transfer of motorcycle and off-highway vehicle operator training programs to the Texas Department of Licensing and Regulation, by the Eighty-sixth Legislature, Regular Session, \$2,070,299 in the Motorcycle Safety Fund in fiscal year 2020 and \$2,070,299 in the Motorcycle Safety Fund in fiscal year 2021 are reduced from the Department of Public Safety. In addition, the nine fulltime-equivalent positions that are appropriated to the Department of Public Safety by this Act for the motorcycle and off-highway vehicle operator training programs for the 2020-21 fiscal biennium shall be transferred to Texas Department of Licensing and Regulation.

Article IX Proposed Contingency Rider for Senate Bill 621

Overview

The following action adds a new rider that would appropriate funds to the Texas Department of Licensing and Regulation, and reduce appropriations for the Texas State Board of Plumbing Examiners, contingent on the enactment of Senate Bill 621 or similar legislation related to the transfer of regulation of plumbing to the Texas Department of Licensing and Regulation.

Required Action

On page IX-xx, add the following new rider:

Section 18.xx. Contingency for Senate Bill 621.

- a. Contingent on the enactment of Senate Bill 621, or similar legislation relating to the transfer of regulation of plumbing to the Texas Department of Licensing and Regulation, by the Eighty-sixth Legislature, Regular Session, \$2,604,379 in General Revenue in fiscal year 2020 and \$2,604,379 in General Revenue in fiscal year 2021 and \$49,700 in Appropriated Receipts in each fiscal year are reduced from the Texas State Board of Plumbing Examiners.
- b. Contingent on the enactment of Senate Bill 621, or similar legislation relating to the transfer of regulation of plumbing to the Texas Department of Licensing and Regulation, by the Eighty-sixth Legislature, Regular Session, the Texas Department of Licensing and Regulation is appropriated \$2,852,764 in General Revenue in fiscal year 2020 and \$2,923,709 in General Revenue in fiscal year 2021 to implement the provisions of the legislation. In addition, all fulltime-equivalent positions that are appropriated to the Texas State Board of Plumbing Examiners by this Act for the 2020-21 fiscal biennium shall be transferred to Texas Department of Licensing and Regulation.
- c. Contingent on the enactment of Senate Bill 621, or similar legislation relating to the transfer of regulation of plumbing to the Texas Department of Licensing and Regulation, by the Eighty-sixth Legislature, Regular Session, the allocation of funds to be transferred to the Health Professions Council by the participating agencies for each fiscal year of the 2020-21 biennium as required by Section 3, Special Provisions Relating to All Regulatory Agencies, in Article VIII of this Act, shall be adjusted to reduce funds transferred by the Texas State Board of Plumbing Examiners to the Health Professions Council and reallocate the amount of any decrease in funds transferred to the Health Professions Council by the Texas State Board of Plumbing Examiners for the 2020-21 biennium to the other participating agencies.

Prepare a rider which appropriates proceeds from a state agency's sale of historical collection items and limits the expenditure of the proceeds for the direct care and preservation of historical collections, contingent upon enactment of Senate Bill 605, House Bill 1422, or similar legislation.

Required Action

On page IX-xx, add the following new rider:

Section 18.xx. Contingency for Senate Bill 605. Contingent on enactment of Senate Bill 605, House Bill 1422, or similar legislation relating to the sale of certain historic property, by the Eighty-sixth Legislature, Regular Session, a state agency that sells a qualifying deaccessioned collection item pursuant to the provisions of the legislation is appropriated proceeds from the sale for the purpose of the direct care and preservation of historical collections managed by the agency.
