For the Quarter 2 FY 2025 reporting period, LBB staff asked agencies for additional detail about the balance of unexpended funds for each award. Of the \$8,867,173 in unexpended funds for this authority, agencies report that \$880,711 has lapsed and is unavailable for expenditure. Agencies report that no funds have been obligated, but not yet expended, and a total of \$7,986,462 remains available for obligation and expenditure.
