For the Quarter 2 FY 2025 reporting period, LBB staff asked agencies for additional detail about the balance of unexpended funds for each award. Of the \$840,322 in unexpended funds for this authority, agencies report that \$542,222 has lapsed and is unavailable for expenditure. Agencies report that no funds have been obligated, but not yet expended, and a total of \$298,100 remains available for obligation and expenditure.

### Notes:

- Amounts reflected above are as of February 28, 2025, as reported by state agencies and institutions of higher education. Amounts are subject to change based on final awards, expenditures, and obligations between reporting periods. Awards sent directly to locals from federal agencies are not included in this report.
