



Overall GR funding recommendations represent 100.0 percent of 2012-13 baseline levels. In preparing its Legislative Appropriations Request, TAHC has reallocated GR between its six strategies in 2014-15 from its previous allocation in 2012-13. The reallocation is the result of (1) the projected loss of \$1.3 million in Federal Funds and the agency trying to offset the impact to its core functions with General Revenue; (2) agency redirecting General Revenue between strategies to prioritize funding for agency core animal disease prevention, monitoring, and investigation functions. Recommendations have not altered the allocation between strategies from the agency's submission.

#### **Texas Animal Health Commission Selected Fiscal and Policy Issues**

1. **Cost Recovery for Animal Health Programs.** Prior to the 2012–13 biennium, animal health programs at TAHC were almost entirely funded from General Revenue. At the time the agency had two fees in place (poultry registration and certificates for veterinary health), but fee revenue only covered about four percent of agency appropriations. In its efforts to close the budget gap projected for the 2012–13 biennium, the 82nd Legislature pursued a strategy of making a greater portion of the agency's programs self supporting. The Legislature appropriated funds to the agency at 2010–11 spending levels, but made \$9.9 million and 57.5 FTEs contingent on the passage of legislation allowing the agency to assess additional fees (House Bill 1992, Eighty-second Legislature, Regular Session, 2011) and their receipt.

In July 2011, TAHC adopted revised fee proposals that, assuming a full 12 months of implementation, were projected to raise \$600,000 per year. In August 2012, these revenue projections were revised downwards to \$379,705 annually (see attachment for analysis of agency's current fee structure along with revenue estimates). The revised revenue estimate resulted in TAHC lapsing General Revenue of \$4,780,653 in 2012 and \$4,621,653 in 2013, reducing the agency General Revenue appropriations by 42 percent and total appropriations by 31 percent.

In the 2012–13 Biennium the Commission has not enacted fees for all animal health programs for which the agency incurs a cost. Nor has the commission voted to assess new fees for the transport of certain types of livestock. For example, revenue proposals discussed during the 82<sup>nd</sup> Session estimated that a \$2 per head interstate export fee, based only on cattle exports, could generate as much as \$3.7 million per biennium.

2. Adequacy of 2014–15 Baseline Funding Levels. While recommendations provide General Revenue funding at the agency's baseline request limit, General Revenue baseline funding is approximately 42 percent below the agency's 2010–11 spending levels and below the 2012–13 appropriated amount. The agency notes that it can operate in the short term at its baseline limit; but that this funding level would not allow TAHC to respond adequately in the event of a catastrophic animal disease outbreak. According to the agency, currently TAHC has no field staff west of San Angelo and little or no staff stationed along the border. According to the agency, an additional \$4 million above baseline funding levels (\$3.2 million for agency staffing and \$0.8 million for disease programs) would provide sufficient funding to adequately cover the entire state.

According to TAHC, \$3.2 million above baseline funding would add back 24 FTEs in its Field Operations and Emergency Management functions, allowing it to employ field staff west of San Angelo and staff coverage along the border:

- 10 livestock inspectors
- 3 fever tick inspectors
- 3 veterinarians (2 field and 1 emergency management)
- 3 emergency management staff (2 local planners and 1 state planner)
- 1 compliance investigator
- 2 regional office administrative technicians
- 2 Austin office staff for health certificates and interstate entry permit department

Of this amount, the recommended highest priority for funding would be the livestock and fever tick inspectors along with the field veterinarians. The estimated cost for these additional field staff is approximately \$858,510 in fiscal year 2014 and \$900,633 in fiscal year 2015 (10 livestock and 3 fever tick inspectors at current average annual salary of \$43,376 and 3 veterinarians at current average annual salary of \$98,206).

Self Supporting/Non-self Supporting. The agency's request for additional funds is for General Revenue. Should additional appropriations be given, the Legislature also could fund the agency from Contingent Fee Revenue to the General Revenue Fund. Appropriations from General Revenue would require no legislative action. Additional appropriations made from contingent fee revenue could be awarded but would likely require additional fees or fee structure changes to be enacted by the Animal Health Commission in order to generate the necessary revenues. Additionally, it is worth noting that the statutory authority for the agency to recover costs for animal health programs (House Bill 1992, Eighty-second Legislature, Regular Session, 2011) contains a sunset provision which expires August 31, 2015. If a greater portion of the agency's animal health programs are to be made permanently self supporting, the sunset provision to the agency's fee authority will need to be removed.

## Texas Animal Health Commission Rider Highlights

- 6. (former) **Fee Revenue: Poultry Registration.** Recommendations remove appropriating rider for agency's poultry registration fees to remove duplication as the agency already has authority under Rider 9, Cost Recovery for Animal Health Programs.
- 7. **Allowance for Personally-Owned Horses.** Modifies rider at agency request to provide agency authority to change daily reimbursement rate for employees with personally owned horses from \$50 to \$75. Request was for authority only and modification requires no additional funds.
- 9. **Cost Recovery for Animal Health Programs.** Recommendations adjust the agency's cost recovery rider to fall within range of agency estimated revenues, and do not require the agency to recover any other direct and indirect costs with revenues. The agency estimates generating \$379,705 annually in revenues. The rider also appropriates any revenues above the amount identified in the Comptroller's Biennial Revenue Estimate.
