



Court of Criminal Appeals Selected Fiscal and Policy Issues - House

1. **Judicial Salaries.** Recommendations provide \$3.7 million in All Funds, including \$3.0 million in estimated General Revenue funds, for judicial compensation. This is an estimated increase of \$16,294 above 2022-23 spending levels to cover the salary, benefits, and longevity costs for anticipated increases in judicial tenure at the Court of Criminal Appeals (CCA) during the 2024-25 biennium.

Base salaries for judges of the CCA are linked to the base salary of a district judge under the tiered, tenure-based compensation structure established by Government Code §659.012. Statute sets the base salary for a CCA judge, other than the presiding judge, at 120.0 percent of the district judge base salary (\$168,000) for the first four years of their tenure. When their tenure is between 4 and 8 years, the judge earns 110.0 percent of their \$168,000 base salary (\$184,800). A judge with over 8 years of tenure earns a salary that's 120.0 percent of their \$168,000 base salary (\$201,600).

Judge salaries are funded through an estimated and non-transferrable strategy isolating required compensation appropriations and providing flexibility to adjust funding levels for unanticipated changes in compensation obligations resulting from tenure changes and elections or appointments of persons with years of service credits differing from the previous position holder.

- 2. **Court Funding and Staff Salaries.** Recommendations continue General Revenue appropriations at 2022-23 levels for the Court to address its mandatory caseload of direct appeals of cases in which the death penalty has been imposed and post-conviction applications for writs of habeus corpus. Recommendations do not include \$1.3 million requested by the Court agency to align salaries for CCA FTEs with like positions at the Supreme Court of Texas. (See also, Items Not Included in Recommendations #1.)
- 3. **Judicial Education.** Recommendations provide \$25.9 million in All Funds, which continues 2022-23 spending levels, to provide ongoing education for judges and other court staff during the 2024-25 biennium. This includes \$1.1 million in All Funds to provide training and education related to mental and behavioral health. Judicial Education funding recommendations include the following amounts and methods of finance:
 - \$0.9 million in General Revenue which includes \$0.4 million to contract with statewide professional associations and other entities whose purposes include continuing legal education for judges and court staff on mental health issues and pre-trial diversion and \$0.5 million to train, educate, and inform judges and their staff about mental health care resources available in Texas; and
 - \$25.1 million in GR-Dedicated Judicial Court and Personnel Training Fund No. 540 (GR-D Fund 540) to provide grants funding for legal education and training for judges, prosecutors and staff, defense attorneys and staff, clerks and court personnel, and public defenders, including \$0.3 million for providing judicial education services and training on indigent defendants and mental health.

GR-D Fund 540 revenues include 3.3224 percent of court costs paid by people convicted of an offense; a portion of the filing fees paid to a court clerk by people filing civil, probate, guardianship, or mental health cases in a district court, statutory county court, statutory probate court, or county court; and other fees, not to exceed \$50, collected by the Supreme Court of Texas and the 14 Courts of Appeals.

Recommendations continue funding from GR-D Fund 540 at 2022-23 spending levels with estimated appropriation authority to allow for any additional revenues received to be spent for the same purpose.

Recommendations do not include \$0.2 million in General Revenue requested by the agency to provide additional continuing legal education to public defenders. (See also, Items Not Included in Recommendations #2.)

4. **Unexpended Balance Authority.** Recommendations continue the Court's Unexpended Balance authority but remove the strategy-level designations in the bill pattern and include a new Special Provisions – Judiciary rider providing the same authority for all Article IV courts and agencies.
