

Health Professions Council Selected Fiscal and Policy Issues - Senate

- 1. **Transfers**. The agency's funding is set in Section 3 of the Special Provisions to All Regulatory Agencies at the end of Article VIII. The section states that agencies participating in the Health Professions Council (HPC) and the HPC Shared Regulatory Database shall transfer funds through interagency contract to the council. Member agencies draft a memoradum of understanding (MOU) that defines their respective share of the cost burden of operating HPC during a biennium based on workload share and overall agency budget.
- 2. Total Funding Allocation for Member Agencies. Recommendations include funding for the Health Professions Council (HPC) with a net increase of \$120,249 as compared to allocations approved by the 83rd Legislature due to an increase in funding to annualize salaries at the 2015 level, increased Data Center maintenance costs, and changes in HPC participation levels by the member agencies. Information in the following tables aligns with the informational rider in Special Provision of Article VIII, Section 3, Funding for Health Professions Council.

3. HPC Shared Regulatory Database. Recommendations in Table 1 include the amounts of interagency transfers intended for the operation and maintenance of the Health Professions Council Shared Regulatory Database in Table 2. A net increase of \$16,739 compared to allocations approved by the 83rd Legislature is due to changes in HPC participation levels by member agencies and increased Data Center maintenance costs.
