



Judiciary Section, Comptroller's Department Selected Fiscal and Policy Issues - Senate

1. Judge and Prosecutor Compensation.

Government Code §659.012, Judicial Salaries, and §46.003, Compensation of State Prosecutors, establish a tiered, tenure-based compensation structure for certain judges and professional prosecutors that is linked to the base salary of a district judge and adjusts depending on the judge or professional prosecutor's tenure. For their first four years of service, the judge or the professional prosecutor earns a base salary that is a certain percentage of the base salary of a district judge. When their tenure is between 4-8 years of service, the judge or professional prosecutor earns 110 percent of their base salary. With 8 or more years of tenure, the judge or professional prosecutor's salary is 120 percent of their base salary.

Recommendations include \$191.2 million in All Funds, including \$166.7 million in estimated General Revenue funding and \$24.5 million from Judicial Fund No. 573 for judicial salaries and other expenses and \$61.8 million in All Funds, including \$42.2 million in Estimated General Revenue and \$19.5 million from Judicial Fund No. 5073 to provide salaries and other expenses for prosecutors.

Recommendations maintain estimated appropriation authority for all judge and prosecutor compensation strategies, assistant prosecutor longevity pay, county attorney salary supplements, witness expenses, death penalty representation, juror pay, and indigent inmate defense.

Recommendations do not include \$47.7 million in General Revenue at the Judiciary Section, Comptroller's Department (CPA-J) requested by the Judicial Compensation Commission to provide an 11.0 percent increase in district judge salaries in 2024 and an 11.0 percent increase in district judge salaries in 2025. The district judge base salary is set in the GAA (at an amount not less than \$140,000, per Government Code §659.012) and informs salaries paid to prosecutors, appellate judges and justices, and county judges. The LARs for the appellate courts and Office of the State Prosecuting Attorney do not include a fiscal impact from this item. (See also, Items Not Included in Recommendations #1- #10.)

- Visiting Judge Program Funding. Recommendations provide \$27.6 million in General Revenue for Appellate and Regional Visiting Judge Programs, which is an increase of \$7.9 million above 2022-23 spending levels. This includes replacing and biennializing \$7.0 million in Federal American Rescue Plan Act funds provided in SB 8, Eighty-seventh Legislature, Third Called Session, 2021, to address court case backlogs that are no longer available with \$14.0 million in General Revenue. Also included is an additional \$0.9 million in General Revenue to biennialize an equivalent amount provided in HB 9, Eighty-seventh Legislature, Second Called Session, 2021, for border security purposes.
- 3. **Biennialize Funding for Changes Due to Enactment of House Bill 3774, Eighty-seventh Legislature, 2021.** Recommendations include biennialized funding for the following:
 - A. **District Courts:** an increase of \$0.4 million in General Revenue to biennialize costs for 10 district courts, five statutory county-courts-at-law, and one new statutory probate court that were established during the 2022-23 biennium;
 - B. **Statutory County Courts:** an increase of \$0.2 million in General Revenue to biennialize costs for increasing the amount the state reimburses counties with statutory probate judges from \$40,000 to \$84,000 annually.
- 4. **Professional Prosecutor Office Apportionment.** Recommendations provide \$8.3 million in General Revenue, which continues 2022-23 spending levels, to fund office expenses for professional prosecutors. Government Code §46.004 entitles state prosecutors to receive at least \$22,500 each fiscal year in state funding to help defray office expenses.
- 5. **Judicial Fund No. 573.** Recommendations provide \$92.8 million from Judicial Fund No. 573 to pay judicial and prosecutorial salaries, an increase of \$0.4 million over 2022-23 spending levels.

Judicial Fund No. 573 revenues include 12.6667 percent of court costs paid by people convicted of an offense; a portion of the filing fees paid to a court clerk by people filing civil, probate, guardianship, or mental health cases in a district court, statutory county court, statutory probate court, or county court; other fees, not to exceed \$50, collected by the Supreme Court of Texas (SCOT) and the 14 Courts of Appeals (14 COAs); civil penalties recovered by the attorney; and settlements and penalties collected by district or county attorneys for certain civil liability cases. Appropriations from Judicial Fund No. 573 fund district judge and professional prosecutor salaries at the CPA-J; appellate judicial salaries at the SCOT, the Court of Criminal Appeals, and the 14 COAs; and the Basic Civil Legal Services program and other operations at SCOT.

The Comptroller's Biennial Revenue Estimate (BRE) estimates revenues and available fund balances will total \$268.0 million for the 2024-25 biennium. Recommendations for CPA-J and the appellate courts, including employee benefit and retirement costs, for the 2024-25 biennium total \$142.4 million. Although the BRE estimates that available balances and revenues deposited to Judicial Fund No. 573 will be sufficient to cover recommendations for CPA-J and the appellate courts, recommendations also continue estimated appropriation authority from General Revenue to cover any possible shortfalls.

6. **Longevity Pay Supplement for Prosecutors.** Recommendations provide an estimated \$9.5 million in All Funds, including \$2.9 million in General Revenue and \$6.5 from Assistant State Prosecutor Fund No. 303 (Fund No. 303), for longevity pay for eligible assistant district attorneys. (The totals do not sum because of rounding.)

²Government Code §46.0031 entitles a county prosecutor to a state supplemental salary equal to between one-sixth and one-half of the state base salary of a district judge with comparable years of service dependent on the number of counties served by the county prosecutor.

This includes a \$0.1 million increase in General Revenue from 2022–23 spending levels for an increased number of assistant county prosecutors participating in the longevity program. Pursuant to Government Code, Chapter 41, every full-time assistant prosecutor is entitled to monthly longevity pay from the state of \$20 per year of service starting in their 5th year. Recommendations continue estimated appropriation authority to provide the CPA-J with necessary flexibility to meet statutory obligations for paying longevity supplements to eligible assistant prosecutors.

Fund No. 303's revenue includes two-thirds of each \$15 fee paid by a surety posting a bail bond. According to the BRE, revenues that will be deposited to the credit of this account are estimated to be \$7.1 million for the 2024–25 biennium.

7. **Juror Pay.** Recommendations provide an estimated \$27.5 million from Jury Service Fund No. 328 (Fund No. 328), a \$0.1 million reduction in All Funds, to provide juror reimbursements to counties. This includes an anticipated \$1.0 million increase in revenue to Fund No 328 offsetting a \$1.2 million decrease in General Revenue for one-time costs to cover revenue shortfalls in Fund. No 328 during the 2022-23 biennium. The overall funding reduction is due to fewer jury trials being anticipated in the 2024-25 biennium than in 2022-23, due to a backlog of cases from the COVID pandemic having been cleared.

Recommendations continue estimated appropriation authority to provide CPA-J with necessary flexibility to meet statutory obligations for state funding of juror pay. Fund No. 303 revenues include 6.4090 percent of court costs paid by people convicted of an offense. Statute requires fund balances exceeding \$10.0 million to be transferred to General Revenue-Dedicated Account No. 5073, Fair Defense.

8. **Special Prosecution Unit (SPU):** Recommendations include \$11.5 million for the Special Prosecution Unit, Walker County, an increase of \$0.6 million, or 5.1 percent from 2022-23 levels. The total includes \$8.5 million in General Revenue and \$3.0 million in Other Funds from Criminal Justice Division Grants to CPA-J. SPU has three divisions (Criminal, Juvenile, and Civil) and is headquartered in Huntsville. SPU's employees and executive director receive their salary, health insurance, and retirement benefits from Walker County. A portion of SPU's appropriation pays Walker County to administer its payroll and benefits.

Recommendations do not include \$1.4 million in General Revenue requested by SPU, including:

- \$0.2 million for anticipated increases in health insurance and other employee benefit costs provided by Walker County;
- \$0.1 million in additional funding for salary adjustments and Walker County benefit costs related to the statewide salary adjustments found in strategy items contained in agency bill patterns; provide a 20.0 percent salary increase for 9.0 criminal investigator FTEs;
- \$0.1 million to increase the Executive Director's salary to that of a district attorney with comparable years of service under the tiered, tenure-based compensation structure for prosecutors established by Government Code §659.012;
- \$0.9 million to provide to salary parity for 43 SPU FTEs with equivalent Walker County criminal investigator, prosecutor, and support staff FTE positions;
- \$0.1 million for increased expert witness fees for civil commitment cases; and
- \$35,000 for increased fuel costs for traveling. (See also, Items Not Included in Recommendations #11.)
