

Agency Budget and Policy Issues and/or Highlights



Texas A&M AgriLife Extension Service Selected Fiscal and Policy Issues - Senate

- 1. Infrastructure Support. Funding to Texas A&M System agencies for Infrastructure Support Within Brazos County is calculated using the General Academic Institutions' Infrastructure Support formula rate. Texas A&M System agricultural agencies (including Texas A&M AgriLife Extension) also receive funding for Infrastructure Support Outside Brazos County through a sum-certain appropriation. The infrastructure support funds included in the recommendations for within Brazos County are at the 2024-25 Texas A&M University infrastructure rate, multiplied by the agencies' fiscal 2021 predicted square footage.
- 2. **Experimental Use Program for Feral Hog Abatement.** In the Eighty-seventh Legislature, 2021, AgriLife Extension received \$250,000 in each fiscal year of the 2022-23 biennium to implement an experimental use program for the purpose of advising the Texas Department of Agriculture regarding pesticide products containing warfarin that are registered by the U.S. Environmental Protection Agency for use to control feral hogs. AgriLife Extension will submit a report to the legislature and the Department of Agriculture by August 31, 2023, regarding the results of the experimental use for each pesticide product evaluated under the program. Recommendations do not include ongoing funding for the experimental use program in the 2024-25 biennium, after AgriLife Extension submits its report and the Department of Agriculture determines whether the use of a pesticide product containing warfarin is safe and effective.

- 8. Experimental Use Program for Feral Hog Abatement. This rider directed \$250,000 in General Revenue in each fiscal year of the 2022-23 biennium to be used to implement an experimental use program for the purpose of advising the Texas Department of Agriculture (TDA) regarding pesticide products containing warfarin that are registered by the U.S. Environmental Protection Agency for use to control feral hogs. The rider directs the Texas A&M AgriLife Extension to submit a report to the legislature and TDA regarding the results of the program by August 31, 2023. Recommendations include deletion of this rider as the agency expects to submit the report on time.
- 12. Grape Crush Report. This rider directed the agency to complete a grape crush report for the assessment of the State's grape crop and directed \$15,000 in General Revenue from Strategy B.1.1 in fiscal year 2022 for that purpose. This rider was considered one-time and is not included in recommendations.
